<b>Licensing</b>	Included with EasyLobby SVM software; Self Registration is a mode of running the software and requires a log in and password to launch	Separate license required for each eKiosk workstation. eKiosk workstations must be tied back to an EasyLobby SVM license. You may have multiple eKiosk licenses tied to a single SVM instance.
<b>Language Support</b>	English, Spanish, French, German, Italian, Portuguese, Danish and Welsh	English
<b>Compatible with eAdvance Preregistration</b>	Yes	Yes
<b>ID Scanning</b>	Yes	No
<b>Photo Capture</b>	Yes	No
<b>Badge Printing</b>	At Self Registration workstation or at a separate SVM workstation	Only through proxy printing at separate SVM workstation
<b>Document Display</b>	Yes, Can be acknowledged onscreen or on signature pad	Yes (document display only)
<b>Notifications</b>	Optional visitor check in notification to Employee	Optional visitor check in notification to Employee
<b>Watch List and Screening Service Verification</b>	Yes, Self Registration mode runs any specified watch list or screening service checks. Potential matches are reviewed by EasyLobby SVM operator at a manned workstation.	eKiosk supports Watch List checks, but cannot screen against external screening services.
<b>Set Up and Configuration</b>	Configuration managed through EasyLobby SVM Program Options - Self Registration menus. Details are included in the EasyLobby SVM Installation, Administration, and User Guide (PLT-03258).	Configuration managed through EasyLobby SVM Program Options - Self Registration - Hidden or Required Fields. Behavior Options are limited, as specified in the eKiosk Installation, Administration, and User Guide (PLT-03267). <b>Workstation Form Factors</b>	Traditional or touchscreen PC, stand-alone kiosk (3rd party provided), or Windows-based tablet	Any internet enabled tablet or PC Please note that installation and configuration must be done on an IIS Webserver on a Windows-compatible device before browsing to the eKiosk URL from the tablet.
